- The EMD has been fixed for the convenience of the bidders, however post-approval of contracts, for any particular bidder, if the amount of EMD is not sufficient with respect to tentative quantity for maintaining 1.40 % of the trade value with the NCDFI eMarket, the respective member (winning bidder) has to deposit the balance EMD to comply with 1.40 % EMD Requirement. In such a scenario the Bid

Evaluation Result will be issued in favor of the bidder only after the deposition of the balance amount with the NCDFI Market.

7. Every quarter TC/TDS settlement will happen based on actual work value. Please share details of work value at the end of every quarter of the contract period. If Required EMD is less than 1.4% then Balance EMD will be collected from Contracted Vendor every quarter.

8. Transaction Charges: Transaction fee @ 0.30% (Exclusive of GST) shall be deducted on confirmation of completion of Contract by Mother Dairy. The EMD of the successful winner will be refunded after deducting applicable transaction charges (0.3 % of trade value + GST) by NCDFI eMarket. In case the transaction charges exceeds the EMD amount bidder will have to deposit the difference amount in the respective ICICI Escrow account.

9. EMD will be blocked for all participants until final confirmation is received from MDFVPL.
