1. Rate to be quoted in Rs. per KG basis. Rate should be quoted per kgs. basis inclusive NGT, toll tax, Loading, unloading while mandi fee extra on actual basis.
2. The quotes shall be applicable on prevailing diesel price 87.62 ₹/L Jul 11, 2024 (Delhi)
3. Closed body vehicle with 9 MT capacity & ventilation is preferred in this requirement.
4. Contract period - Tentative contract period: 10th Aug'24 - 25th Oct'24 or season last
5. Bidder should have a minimum 18-20 vehicles.
6. Eligibility Criteria:

- Interested Vendors declare at least one year experience of transportation in the similar industry.
- Signed Terms and Conditions from signing authority.
- RC of 2-3 vehicles for 9MT Passing fleet.
- FSSAI License.
- Registration certificate, (Vehicle should be in the name of owner, Relative or Company Name. Relative” in relation to the bidder, means the husband, wife, brother or sister or any lineal ascendant or descendant of the bidder).
- Vehicle age should be defined as per the government norms (as per the RTO / Motor Act).

7. Transaction Charges: TC @ 0.3% of contract value (plus GST) and advance TDS @ 1% of the projected contract value will be deducted based on the approved advance trade value from the deposited EMD on a quarterly basis. At the end of every quarter, Mother Dairy will communicate the actual trade value for every vendor in the contract. Based on the shared actual data, the TDS and TC will be deducted/adjusted for the next quarter vendor-wise. If at any point in time, EMD of Rs.2 lakhs is found to be insufficient, the vendor needs to deposit Balance EMD to continue the contracted transportation. At the end of the contract period, TC will be adjusted as per actuals for full and final adjustments and balance EMD will be released.

8. Forfeiture of EMD: The EMD submitted by the Bidder shall be forfeited in any of the following conditions. However, MDFVPL reserves the right to override any of the following conditions at its sole discretion. The Bidder withdraws his Bid after submitting the same. The Bidder withdraws his Bid after the Notification of Award. The selected Bidder withdraws the proposal before submitting the Security deposit. Failure to accept the order by the selected Bidder within 7 days from the date of receipt of the notification of Award.

9. EMD will be blocked for all participants until final confirmation is received from Mother Dairy.

10. BOQ may be allocated to one or multiple bidders at Mother Dairy’s discretion.

11. MDFVPL at its own discretion can have multiple rounds of negotiation offline/online/ through reverse auctions among the technical evaluated bidders

12. FSSAI license validity shall maintain by the transporter otherwise there may be penalty of Rs. 5000 per trip due to non-availability/no valid license of vehicle.

13. No entry permission in Delhi can be an advantage if available for fast transportation.

14. No. of trips may be variable as according to business requirement like Jubbal (HP) to Kundli may be around 100 & others routes may be less/more up to +/- 30 %.
