- MDFVPL at its own discretion can award the routes to multiple bidders.
- MDFVPL at its own discretion can have multiple rounds of negotiation offline/online/ through reverse auctions among the technical evaluated bidders.
- Contract duration:6 Month(Tentatively Oct'24-Mar'25).
- Diesel Price INR **87.62 per Liter at Delhi** as Dated 24th July, 2024 will be considered as base fuel rate.
- Eligibility Criteria :**
 - Vendors bidding for e-auction must have valid FSSAI License with "**C**" **Form(if Available)**. **However** Product Category 2 (**Fats and oils, and fat emulsions**) is Mandatory to participate in the Tender.
 - Carrier Registration Certificate is required for all bidders for Insurance claim purpose. In absence of this document, If any claim will be rejected or short claim passed against the insurance claim, The same cost to be borne by Service provider.
 - Service providers having company/Group Turnover Equal or above Rs 15 Cr. (Fifteen Cr.) shall be eligible to participate for Pan India.
 - Service Providers having company/Group Turnover equal or more than Rs03 Cr (Three Cr) shall be eligible to Participate for Latur, Vashi, Chennai, Dhuri and Bharampuri Source location Only.
 - Atleast one year experience of transportation in similar industry (FMCG).
- Transaction Charges:** TC@0.2% of contract value (plus GST) and advance TDS@1% of the actual contract value. Mother Dairy will communicate the actual trade value for every vendor in the contract. Based on the shared actual data, the TDS and TC will be deducted/adjusted for the next quarter vendor-wise. If at any point in time, EMD is found to be insufficient, the vendor needs to deposit Balance EMD to continue the contracted transportation. At the end of the contract period, TC will be adjusted as per actuals for full and final adjustments and balance EMD will be released.

7. **Forfeiture of EMD:** The EMD submitted by the Bidder shall be forfeited in any of the following conditions. However, MDFVPL reserves the right to override any of the following conditions at its sole discretion. The Bidder withdraws his Bid after submitting the same. The Bidder withdraws his Bid after the Notification of Award. The selected Bidder withdraws the proposal before submitting the Security deposit. Failure to accept the order by the selected Bidder within 7 days from the date of receipt of the notification of Award.

8. EMD will be blocked for all participants until final confirmation is received from MDFVPL.

9. BOQ may be allocated to one or multiple bidders at Mother Dairy's discretion.
