### Additional Notes

**Note:**

- The rates quoted shall be FOR (inclusive duties, freight, insurance, delivery & other incidental charges for supply of item/material at Delivery locations) GST will be extra.
- The NCDFI eMarket transaction fees (i.e. 0.4% of trade value + GST) would be deducted from the EMD of the suppliers held at NCDFI on actual supply after getting the confirmation from Mother Dairy.
- Breakup: The successful bidder must provide a complete breakup of the quoted price.
- TDS amount (1.00 % of total trade value) is included in EMD.
- Polymer Prices will be revised the 1st of every month based on Reliance depot price and the same will be effective 5th of the same month.
- The quantities mentioned are tentative and may change according to business requirements.
- The NCDFI eMarket transaction fee, which is 0.4% of the trade value plus GST, will be deducted from the supplier's Earnest Money Deposit (EMD) upon actual supply after confirmation from Mother Dairy. Additionally, a Tax Deducted at Source (TDS) under section 194-O at 1% of the contract value will be deducted from the EMD.

8. The successful bidder must provide a detailed breakup of the quoted price.

9. Lead time 15 days from the date of PO .

10. Contract Period - One year (August 24 to July 25)

**The bidder needs to submit the EMD amount (Rs. 5,00,000) to the NCDFI ESCROW account to participate in the auction. The EMD has been fixed for the convenience of the bidders, however post-approval of contracts, for any particular bidder, if the amount of EMD is not sufficient with respect to tentative quantity for maintaining 2.50 % of the trade value with the NCDFI eMarket, the respective member (winning bidder) has to deposit the balance EMD to comply with 2.50 % EMD Requirement. In such a scenario the Bid Evaluation Result will be issued in favor of the bidder only after the deposition of the balance amount with the NCDFI eMarket.**
