In such a scenario the Bid Evaluation Result will be issued in favour of the bidder only after deposition of the balance amount with the NCDFI Market.
- Bidders are also required to submit EMD 2 days prior to the auction. Late submission of EMD will not be entertained and members will not be allowed to participate in the auction.
