1. Rate to be quoted in Rs. per Fixed cost per month per vehicle and Variable cost per km. Freight should be inclusive of all taxes (Including Green Tax, Warai/Mathadi, Loading & unloading charge.) & Exclusive of GST

2. Base rate of quote is average of Sep-24 as CNG rate Rs 75.09.

3. Contract duration: Tentative Feb'2025 - Jan'2030 (3+ 2 year)

4. Loading and unloading of stock & EMPTY Crate will be responsibility of the vendor.

5. Eligibility Criteria :-

- Valid FSSAI license (Mandatory 01 & 04 category).
- Vendor should have 3 years of experience in cold chain.

- Signed and stamp of T&C.
- Bidder should have 15 vehicles in his name or, Relative or Company Name and should submit the copy of proof of RC. “Relative” in relation to the bidder, means the husband, wife, brother or sister or any lineal ascendant or descendant of the bidder.

**6. Transaction Charges:** TC @ 0.3% of contract value (plus GST) and advance TDS @ 0.1% of the projected contract value will be deducted based on the approved advance trade value from the deposited EMD on a quarterly basis. At the end of every quarter, Mother Dairy will communicate the actual trade value for every vendor in the contract. Based on the shared actual data, the TDS and TC will be deducted/adjusted for the next quarter vendor-wise. If EMD is found to be insufficient, the vendor needs to deposit Balance EMD to continue the contracted transportation.

**7. Forfeiture of EMD:** MDFVPL reserves the right to override any of the following conditions at its sole discretion. The Bidder withdraws his Bid after submitting the same. The Bidder withdraws his Bid after the Notification of Award. The selected Bidder withdraws the proposal before submitting the Security deposit. Failure to accept the order by the selected Bidder within 7 days from the date of receipt of the notification of Award.

**8. Lowest bid will be finalized based on a grand total basis {5 yrs cost, that is 3 yr+2 yr} provided each vendor will put rates on each line item.**

**9. The vehicle should not be older than 5 yrs.**

**10. Rate Validity is for 5 yrs. (rates to be put separately for first 3 yrs and next 2 yrs).**

**11. All the vehicles should be complied with RTO norms under vehicle act and amendment thereof in case there will be any change in law or continuous vehicle breakdown then vendor has to replace the existing vehicle with the new replacement as per the applicable laws.**

**12. MDFVPL at its own discretion can have multiple rounds of negotiation offline/online/ through reverse auctions among the technically evaluated bidders.**

**13. MDFVPL at its own discretion can allocate the number of vehicles to multiple bidders.**

**14. For No entry permit vendor to provide the necessary evidence of registering their vehicles on the respective government portal within the 90 days from the award of contract.**

**15. EMD will be blocked for all participants until final confirmation is received from Mother Dairy.**
