- The rates for each item should be quoted **exclusive of GST** which will be charged extra from the contractors as applicable at the time of lifting of items as per rules. The successful bidder shall have to commence the lifting of the materials **from respective Federation Milk Shed** within 10 days from the date of receipt of contract letter duly fulfilling the formalities of the tender schedule. The successful bidder shall have to lift the available scrap within 3 Months from the provide schedule from seller.
- The period of contract for the disposal of items indicated in the schedule is for 3 months from date of Finalization. The contract for the disposal of scrap materials can be extended for further period of 3 months or more on mutual acceptance and at the discretion

of the **Managing Director, TGDDCF Ltd.**

4. The approved contractor should **start to lift the accumulated quantity within 10 days**, if fails to lift the material within 3 months from the date of receipt of communication or any other specified time limit, it shall be open for the disposal in public auction/ sealed quotation and the losses if any, sustained will be recovered from the approved bidder.
- Bidders need to quote Ex-CFP rate in Rs/Lot mentioned above exclusive of applicable GST and other expenditures.
 - '0.1% TDS u/s 194 (O) will be deducted from seller's EMD on projected trade value at the time of issuance of Bid Evaluation Result.'
