6. The EMD shall be liable for forfeiture if the winning bidder does not execute the contract and fails to furnish the Security Deposit. The EMD will not carry any interest.

**7. SECURITY DEPOSIT:** - 5 % of order amount shall be held as security deposit from outstanding bills & shall be released within 5 days of completing the supplies. If supplies are not completed by due date of purchase order & Mother Dairy shall be free to purchase the briquette from open market at the risk & cost of Supplier which will be subsequently recovered from vendor.

8. The supplier strictly needs to follow the SOP provided in the Terms & Conditions for supplying the material.

On confirmation of receipt of the material by Mother Dairy Tirupati, the EMD of the successful winner will be refunded after deducting the applicable transaction charges (0.4 % of trade value + GST). TDS (u/s 194-O) @ 0.1% of the contract value will be deducted from the EMD.

**Forfeiture of EMD:** The EMD submitted by the Vendor shall be forfeited in any of the following conditions. However, Mother Dairy Tirupati reserves the right to override any of the following conditions at its sole discretion:

1. The Vendor withdraws his Bid after submitting the same.
2. The Vendor withdraws his Bid after the Notification of the Award.
3. Failure to accept the order by the selected Vendor within the stipulated date of receipt of the notification of Award.
