<p>1. Quotation to be submitted on Trip basis and exclusive of GST.</p> <p>2. Freight rate should include toll tax/Green tax and loading/unloading/Warai/Parking and all pocket expenses.</p> <p>3. Base rate of quote is average Aug 2025 Diesel rate of 87.66/- Avg. Diesel Hike = (Current rate - Base rate) / (Average km running per litre of fuel) * Km Run</p> <p>4. MDFVPL at its own discretion can have multiple rounds of negotiation offline/online/ through reverse auctions among the technical evaluated bidders.</p> <p>5. Forfeiture of EMD: The EMD submitted by the Bidder shall be forfeited in any of the following conditions. 7. Eligibility criteria :-

- The transporter shall have a minimum 1 year of experience in the similar industry (FMCG).
- 3 Cr turnover for the last FY.
- Valid FSSAI License
- Signed and stamped Terms and conditions

8. Vehicle must carry relevant documents (RC, Insurance, Pollution Certificates, and Fitness Certificate etc.) and valid FSSAI license.

9. The EMD has been fixed for the convenience of the bidders, however post-approval of contracts, for any particular bidder, if the amount of EMD is not sufficient with respect to tentative quantity for maintaining 0.5 % of the trade value with the NCDFI eMarket, the respective member (winning bidder) has to deposit the balance EMD to comply with 0.5% EMD Requirement. In such a scenario the Bid Evaluation Result will be issued in favor of the bidder only after the deposition of the balance amount with the NCDFI Market.

10. Transaction Charges: TC @ 0.3% of contract value (plus GST) and TDS @ 0.1% of the actual value will be deducted based on the approved advance trade value from the deposited EMD on a quarterly basis. At the end of every quarter, Mother Dairy will communicate the actual trade value for every vendor in the contract. Based on the shared actual data, the TDS and TC will be deducted/adjusted for the next quarter vendor-wise. If at any point in time, EMD is found to be insufficient, the vendor needs to deposit Balance EMD to continue the contracted transportation. At the end of the contract period, TC will be adjusted as per actuals for full and final adjustments and balance EMD will be released.

11. EMD will be blocked for all participants until final confirmation is received from MDFVPL.

12. BOQ may be allocated to one or multiple bidders at Mother Dairy's discretion.

13. MDFVPL at its own discretion can award the routes to multiple bidders. Share supporting documents as per Eligibility
