The received coal will be tested with a third-party agency(NABL approved) for the respective parameters, any discrepancy found will lead to deduction as per attached sheet.

1. Basic rate should be included all statutory costs, Transportation, Compensation, Material loading, and material unloading. (Door delivery). **GST will be Extra.** Delivery Terms – Free Delivery, MDFVPL, Nagari, Ranchi (Must includes all the loading, unloading, toll, other charges, MDFVPL, Ranchi will not pay any additional charges)
2. EMD of the successful bidder will be released after getting confirmation of the completion of supply from MDFVPL after deducting NCDFI eMarket Transaction Charges (0.4% of Contract Value plus GST). TDS (u/s 194-O) @ 0.1% of the contract value will be deducted from EMD.
3. Coal shall be supplied within 24hrs of placing the requirement either by phone/email/personal visit or any other means of communication. An appropriate amount will be debited to the supplier if the supplier fails to supply coal within the timeline.
4. Vendor will have to supply coal as per mentioned GCV of coal only. MDFVPL, Ranchi will check coal in the lab and release the payment as per actual received of Coal GCV within 15 days, if found below G-10 value and mentioned specification; then the full vehicle

will be rejected or as per GCV calculation, appropriate (up to 50% amount) amount will be debited. The received coal will be tested with a third-party agency(NABL approved) for the respective parameters, any discrepancy found will lead to deduction as per attached sheet.

5. MDFVPL Ranchi does not bind itself to accept & consider the lowest bid and reserves the right to accept or reject any or all the bids in full or part without assigning any reason thereof. MDFVPL Ranchi also reserves the right to divide the ARC/PO to more than one supplier.

6. Every Month TC/TDS settlement will happen based on actual work value. Please share details of work value at the end of every month of the contract period. If Required EMD is less than 1.50% then Balance EMD will be collected from Contracted Vendor or may be settled from Mother Dairy's Payment against actual supplies to the Vendor.

The actual Business quantity will be decided by the Mother Dairy and can vary to any extent.

**Forfeiture of EMD:** The EMD submitted by the Vendor shall be forfeited in any of the following conditions. However, Mother Dairy Fruits & Vegetables Pvt Ltd reserves the right to override any of the following conditions at its sole discretion:
