Terms & Conditions for NCDFI eAuction System for sale of milk

The Sangamner Taluka Sahakari Dudh Utpadak & Prakriya Sangh Maryadit, Sangamner invites bids for eAuctions floated through NCDFI eMarket for sale of Raw Chilled Milk. Bidders, who are interested to participate in the eAuctions are requested to offer their rates for supply of milk from each dairy/Chilling centre.

PART A: General Conditions

- · The Bids should be for per litre on ex dairy / CC basis exclusive of all taxes/duties/any levy/charges.
- Milk containing 3.5% fat & 8.5% SNF on ex dairy / CC basis and for increase/decrease of 0.1% FAT & S.N.F. 20 paise & Rs. 1/- shall be paid/reduce.
- Bids should be for a minimum quantity of 10,000 litres per day.
- Sangamner Taluka Sahakari Dudh Utpadak & Prakriya Sangh Maryadit, Sangamner reserves the right to accept or reject any bid or to annul the bidding process and reject all bids, at any time prior to award of contract without assigning any reason whatsoever and without thereby incurring any liability to the affected bidder or bidders on the grounds for the Seller's action.
- · The bid should be valid for 02 working days from the date of e Auction.
- This e-Auction will be a 07 days contract.
- The quantity concluded in the contract is subject to the availability of milk at the respective dairy/chilling centre.
- The concluded rate will be valid for only ruling contract period.
- Minimum of Re.0.10/- per litres should be increase in bid at the time of e-auction.

A limit of 10% of excess or shortage of the sale order quantity is permissible, during the contract period.

EMD: 1% of EMD as per terms of NCDFI eMarket is payable at the time of participation in eAuctions.

- 1.1% EMD will be refunded to buyer after deduction of applicable transaction charges of NCDFI eMarket.
- 2. The following acts of omission/commission of the bidder would lead to forfeiture of EMD:
 - a) Failure of the bidder to lift quantity of milk awarded as per the sale order beyond permissible limit of +/- 10% quantity within the given delivery period, a penalty of 1% of the contract value of the non-lifted quantity milk will be deducted from the EMD.
 - b) The 100% EMD will be forfeited if no milk is lifted by the contractor during the contract period.

Part B(1) - Terms and Conditions for Bidding

- 1. The bidding system is in an internet platform. The site can be accessed through www.ncdfiemarket.com maintained by National Cooperative Dairy Federation of India Ltd (NCDFI) which will be the venue for online bid submission.
- 2. All the registered members of the NCDFI eMarket are eligible to participate in the bidding. The disqualified or debarred vendors are not allowed to participate. The new vendors have to undergo usual registration/approval procedure stipulated by NCDFI eMarket.
 - Prior intimation regarding the eAuction will be given to all the registered members at least 1 day prior to the auction date by email / WhatsApp alerts. Sangamner Taluka Sahakari Dudh Utpadak & Prakriya Sangh Maryadit, Sangamner will not be responsible for any delay in communication in this regard on account of external reasons and therefore buyers are requested to visit the specific website site periodically.

All the timings of the new eAuction system shall be based on the time indicated by the server, hosting the bidding platform.

- Participation or bidding highest rate alone shall not make the 8. Buyers eligible to award orders. The decision with regards to the sale of milk and finalization of quantity are subjected to the discretion of management and can reject the offers without specifying the reason whatsoever.

Part B(2) - Terms and Conditions for Supply

- Milk will be supplied only against 100% advance payment. 1.
- The Quality (Testing procedures of Sangamner Taluka Sahakari 2. Dudh Utpadak & Prakriya Sangh Maryadit, Sangamner) and Quantity as recorded by the dispatching Dairy/Chilling centre will be final for payment and settlement of accounts.
- Supply of 10% of excess or shortage of the sale order quantity shall 3. be permitted for the whole contract duration.
- Minimum 75% of the sale order quantity on daily basis should be 4. lifted. The quantity lifted below the 75% of the sale order quantity on a single day will attract a penalty of Rs.3/- per litre on the differential quantity below75% and actual lifted quantity.
- In case of failure of buyer to take delivery within the stipulated 5. delivery period, NCDFI eMarket / Sangamner Taluka Sahakari Dudh Utpadak & Prakriya Sangh Maryadit, Sangamner will have right to forfeit the EMD. On any grounds extension of the delivery period/contract period will not be considered.
