

1. SUPPLY OF DAIRYWHITNER-20 GM POUCH IN POLYSTER LAMINATE FILM IN MILMA BRAND NAME

Specification:-

1. Material: The Dairy whitener shall have the quality specification of High Fat Dairy Whitener of FSSAI Standard with minimum 20% fat and 18% Sugar and shall confirm to IS 12299:1998.
2. Packing: Material shall be packed in 20 gm laminated pouches in our brand name. It shall be chain of 12 packets with 32 such chains in a carton. The artwork of the laminate will be provided by us. Labeling shall be done as per FSSAI and other statutory requirements.
3. The rate quoted shall be on per Kg basis inclusive of all taxes, packing materials and delivery at our Dairy free of cost

Approximate Quantity required is 36 Metric Tonne to be supplied in 12 equal installments over next 12 months from October 2020.

1. The material shall be FSSAI Complaint and a certificate for the same shall be produced for each supply.
2. . The supplier shall have either a reputed own brand for Dairy Whitener/ custom packing to a reputed brand in India. The annual turnover of the Manufacturer shall be more than 100 crores. Documentary evidence for the same shall be furnished before finalizing the contract
3. The artwork for printing will be provided by us. The printing of laminate and sourcing of packing material shall be done by the supplier
4. The material shall be delivered to our Dairy free of cost as per Purchase Order given separately every month.
5. The manufacturer shall have a valid FSSAI License and ISO: 22000 certification.
6. The product shall have 1 year shelf life from date of supply and any complaint arising during the period shall be addressed by the Manufacturer. An agreement shall be executed for the same.
