Supply, Installation and Commissioning of Tractor and TMR

NDDB Dairy Services, on behalf of Baani Milk Producer Company Limited, Patiala, Punjab, invites **online tenders under Two-Bid System (Technical Bid & Financial Bid)** from eligible and experienced vendors for the **supply, installation and commissioning of Tractor and TMR (Total Mixed Ration Machine)** through NCDFI e-Marketplace.

1. Mode of Tender & Bid System

- Tender shall be processed through **NCDFI e-Marketplace**.
- **Two-Bid System** shall be followed:
 - **Part-I: Technical Bid**
 - **Part-II: Financial Bid**
- Financial Bids of **only technically qualified bidders** shall be opened.
- Evaluation shall be carried out on an **item-wise basis**.

2. Scope of Supply

- TMR (Total Mixed Ration Machine)

3. Eligibility Criteria

The bidder must fulfill the following minimum eligibility conditions:

1. The bidder should have **positive cash flow**.
2. The bidder must be in existence for a minimum of **three (3) years** as on the date of bid submission.
3. The bidder should have executed **at least one supply order** for TMR during the last **three (3) years** in any organization.
4. Documentary evidence such as **Purchase Order / Work Order** must be submitted.

4. Annexure–I: Eligibility & Supporting Documents

(To be submitted along with the Technical Bid)

1. Firm Registration Certificate / Certificate of Incorporation
2. Audited financial statements / CA certificate indicating **positive cash flow**
3. Self-declaration for minimum **3 years of existence**
4. Copy of at least one **Purchase Order / Work Order** executed in last 3 years
5. GST Registration Certificate
6. PAN Card
7. Proof of **EMD submission**

5. Vendor Registration Requirement

- The bidder **must be registered on NCDFI portal**.
- Quotation submission shall be accepted **only through NCDFI portal**.
- Offline bids or bids submitted through any other mode shall **not be considered**.

6. Earnest Money Deposit (EMD)

- **EMD Amount: Rs. 30,000/-**
- EMD shall be deposited **through NEFT/RTGS** in the account of **NCDFI**.
- Vendors are required to deposit the EMD **directly into their respective Escrow Accounts**.
- Bids without valid EMD shall be treated as **non-responsive**.

Deduction from EMD / Security Deposit

After successful completion of the contract, **NCDFI shall deduct:**

- **Transaction Charges (TC):** 0.4% of Trade Value + **18% GST**
 - **TDS:** 0.1% of Trade Value under **Section 194(O)** of the Income Tax Act

7. Security Deposit

- Successful bidder shall submit **Security Deposit in the form of Bank Gurantee @ 5% of Purchase Order value.**
 - Security Deposit shall remain valid till completion of warranty obligations.
 - SD may be adjusted from EMD or recovered from bills, as applicable.

8. Payment Terms

- Payment shall be released **within 30 days** from the date of successful installation and commissioning.
 - Subject to submission of:
 - Valid tax invoice
 - Installation & commissioning report
 - Acceptance certificate

9. Warranty Clause

- Minimum **12 months warranty** from the date of successful installation and commissioning.
 - All defects during warranty shall be rectified **free of cost.**
 - Service response time shall not exceed **72 hours.**
